**ORBIT INTERNATIONAL'S POWER GROUP RECEIVES
NEW ORDERS VALUED AT APPROXIMATELY \$1,200,000**

**Substantial Growth in Backlog at Power Group
*Approximately 100% Higher than Prior Year***

Hauppauge, New York, September 27, 2007—Orbit International Corp. (NASDAQ:ORBT), an electronics manufacturer and software solution provider, today announced that its Power Group, Behlman Electronics, Inc. ("Behlman") has received two new orders for its custom division valued at approximately \$1,200,000. Deliveries under these contracts are expected to commence in the second quarter of 2008 and continue through the first quarter of 2009.

Behlman received an order for approximately \$850,000 for a COTS power supply used by the U.S. Navy to support its anti-submarine and anti-ship surveillance and targeting system. This contract represents a follow-on to an initial order received in December 2006. The initial contract covers a period of five years, and includes program option quantity requirements through 2011, which if exercised could result in the receipt of future orders totaling in excess of \$2,000,000.

Behlman also received an order for approximately \$350,000 for a COTS power supply used in a satellite communications system. This is Behlman's first production order for these units after successful completion of qualification testing in August 2007. Behlman expects to receive additional orders for these units in 2008 and beyond. In addition, Behlman was requested to design and deliver a rugged version of this unit for its customer, which would be used for military shipboard applications. Production orders for this model are also expected in the near future."

Dennis Sunshine, President and Chief Executive Officer of Orbit International Corp., commented, "Behlman continues to be a leader for standard, custom and COTS power solutions, fulfilling customers program requirements for a number of diversified applications. Behlman's ability to modify its standard products to meet specific customer requirements has created significant business opportunities for both new and repeat orders with the potential of follow-on awards that could extend over several years."

Sunshine continued, “The business at our Power Group continues to remain strong, and recent bookings have increased its backlog to a level that is approximately 100% higher than the comparable backlog from the prior year. Our Power Group continues to penetrate a broad range of marketplaces, including Aerospace/Avionics, Defense, Oil and Gas Exploration, Ground Support, Railroad, Shipboard and Utility Automation. The large customer base, and multi-year program opportunities have had a dramatic impact to Behlman’s backlog. This, together with the increased backlog from our Electronics Group, support our confidence that Orbit will have a strong second half of 2007, and is well positioned for continued growth in 2008.”

Orbit International Corp. is involved in the manufacture of customized electronic components and subsystems for military and nonmilitary government applications through its production facilities in Hauppauge, New York and Quakertown, Pennsylvania. Its Behlman Electronics, Inc. subsidiary manufactures and sells high quality commercial power units, AC power sources, frequency converters, uninterruptible power supplies and associated analytical equipment. The Behlman military division designs, manufactures and sells power units and electronic products for measurement and display.
