**ORBIT INTERNATIONAL'S POWER GROUP RECEIVES
NEW ORDERS VALUED AT APPROXIMATELY \$950,000**

Anticipated Follow-On Orders Could Reach \$4,000,000 Over Next Four Years

Hauppauge, New York, April 1, 2009 - Orbit International Corp. (NASDAQ:ORBT), an electronics manufacturer, systems integrator and software solution provider, today announced that its Power Group, Behlman Electronics, Inc. ("Behlman") has received two new contract awards totaling approximately \$950,000. Deliveries under these contracts are expected to commence in the second quarter of 2009 and continue through the fourth quarter of 2009.

The first order, in excess of \$400,000, represents a follow-on order for a hot swappable DC power supply for use in a nuclear power plant control system. Behlman received the initial prototype order for these units in November 2007 and began delivering production units in January 2008. Behlman received follow-on production orders throughout 2008 and based on information received from its customer, is projecting that the potential for future orders could exceed an additional 200 units over the next four years valued at approximately \$4,000,000.

The second order, valued at approximately \$525,000 is for a new COTS power supply for use on the advanced gun control system for the U.S. Navy's DDG-1000 Zumwalt Class Destroyers. Future orders for these power supplies are dependent upon the Navy's funding for additional ships and our customer's ability to identify other applications for this gun control system which it is actively pursuing.

Mark Tublisky, President of Behlman Electronics, Inc., stated, "We are very encouraged by Behlman's large installed base of COTS power supplies that are used on programs which have now entered their production phases and should continue to generate reorder business for several years. With every new order, Behlman continues to enhance its reputation as a premier supplier of custom power solutions."

Their growing base of business, for both commercial and custom power solutions, resulted in this segment once again achieving record bookings and revenues in 2008. With a record backlog entering 2009, we once again expect strong operating results from Behlman in the current year which we expect will complement a stronger operating performance from our Electronics Group."

Its Behlman Electronics, Inc. subsidiary manufactures and sells high quality commercial power units, AC power sources, frequency converters, uninterruptible power supplies and associated analytical equipment. The Behlman military division designs, manufactures and sells power units and electronic products for measurement and display.
